Kaum ob hli, 2018

Nyob Zoo Phoojwng:

Zaj no “Against All Fears” yog cov lus hais txog kuv, phau ntawv no tau ua tawm los muag rau lub Plaub hli ntuj xyoo no. Cov xibhwb uas qhua txog kuv phau ntawv no yog Dr. Bob Jones III, nws hais txog kuv li no tias “Tug neeg tshaj tawm txoj Moo Zoo hauv Vajluskub Qub” los sis “an Old Testament prophet” Dr. Bill Monroe, ua thawj tsav xwb ob tiam nyob rau BBFI, hais tias “Hymers yog Daniyees rau tiam tam sim no” los sis “Hymers is a modern day Daniel” thiab Dr. Herbert Rawlings yog BBF los sis Dr. John Rawling tug tub, thawj tsav xwm nyob rau lub koom haum Rawling Foundation hu ku li no “Yog Amelikas tiag tiag! Yog tug neeg muaj lub zeem muag! Nws lub neej qhia tias nws ua tau ntau yam tseem ceeb...rau tug Tswv Yexus.” Tsis tag li Don Boys hais tias, “Against All Fears yog phau ntawv uas txhua tug yuav tsum tau yeem, tsis yog tias rau cov xibhwb xwb. Hymers yog tug qauv zoo rau txhua tug neeg...Nws lub neej yog yam peb cheem tsum rau sijhawm no – muaj tug yam ntxwv zoo thiab txhawb tau neeg.”

Thaum kuv los hnov txog cov neeg tseem ceeb no hais txog kuv, tej zaum kuv tseem xav tias qhov no tshwm sim tau licas. Kuv pheej xav tias “Nws ua tau tej hauj lwm no licas?” Ua ntej Vajtswv yuav hu kuv los ua nws tes dej num, zoo li Vajtswv tau muaj nqe Vajluskub no rau kuv,

“Kuv ua tau txhua yam los ntawm qhov Vajtswv ua tug txhawb kuv lub zog”
(Filipis 4:13).

Tau 61 xyoo los lawm kuv yeej pom tias cov lus cog tseg saum no yeej muaj tseeb. Vim hauv kuv lub neej yeej ntsib kev sim siab tawm tsam ntau heev. Tiam sis txhua zaug kuv yeej yog tug yeej vim yog kuv lub neej xij rau ntawm Tswv Yexus. Vim yog Yexus twg tau kov yeej txhaum los lawm thiab ua tau ib tug qauv zoo tshaj plaws rau txhuam tug neeg hauv ntiaj teb. Kuv kov yeej txhuam yam vim yog kuv lub neej xib peem rau ntawm Tswv Yexus.

Nov tsuas yog tej yam uas qhia txog “Kev tawm tsam yam teeb meem loj tshaj plaws. Txhua yam kev tawm tsam yog qhov tiv thaiv Vajluskub xwb, vim cov xibhwb uas qhia nyob hauv tsev kawm Vajluskub qhia yuam kev thiab tawm tsam Vajluskub. Kuv yeej kev sib tawm tsam no vim yog kuv lub neej xib peem rau ntawm Yexus. Tsis tag li kuv tseem tau tawm tsam zaj yeeb-yaj-kiab uas yog “The Last Temptation of Christ,” vim yog lawv hais tias Yexus ua kev nkauj kev dhau nrog rau Malis Madalas. Lub sijhawm no tseem muaj cov tub xov xwm “cuav” cem kuv hais tias yog neeg phem tawm tsam lwm tug. Kuv kuj tau los yeej qhov kev tawm tsam no thiab vim yog kuv lub neej xij peem rau ntawm Tswv Yexus ib leeg xwb. Tom qab ntawd kuv tseem los tawm tsam cov poj niam ua tua cov menyuam hauv plaj. Kws xibhwb John Samuel Cagan, yog ib tug xibhwb uas los pab kuv hais tias “Dr. Hymers coj tag nrho nws cov tswvcuab mus tawm tsam lub tsev khomob ua rho cov menyuam hauv plab no, nws tawm tsam txog rau thaum muab lub tsev no kaw tsis puv muaj ntxiv lawm” Kuv nrog Yexus nyob uake, peb yeej qhov kev tawm tsam no vim peb cia Yexus ua tug coj. Tom qab ntawd yog los tawm tsam cov neeg uas ua kom peb pawg ntseeg tawg tag. Muaj neeg txog li ntawd 320 tug neeg yog cov neeg phaum thiab khiav tamw pawg ntseeg. Thaum kawg peb los yeej cov neeg phem no vim yog “kuv ua tau txhua yuav los ntawm qhov muaj Yexus ua tug txhawb kuv lub zog” Kuv kuv los nyob rau qhov kev sib tawm tsam zoo li no, Kuv yeej paub zoo tias qhov twg yog qhov yog thiab qhov twg yog qhov yuam kev, kuv xaiv qhov yog, thiab yeej txhua zau vim yog “Kuv ua tau txhua yam los ntawm muaj Yexus tua tug txhawb kuv lub zog.”

Lub sijhawm no, coob tug xibhwb tsim tsa lawv pawg ntseeg los ntawm ua tub sab nyhias tswv cuab ntawm lwm pawg ntseeg los xwb, tiam sis kuv tsis tau ua li ntawd, kuv qhov haujlwm yog coj tug neeg uas tsis paub Vajtswv los cuag Vajtswv, yog vim licas? Vim yog “kuv ua tau txhua yam los ntawm muaj Yexus ua tug txhawb kuv lub zog.”

Ntawd yog tias vim licas! Nov yog qhov uas peb yeej thiab tshaj tawm mus thoob plaws ntiaj teb, muaj neeg txog li ntawd 1.5 plhom tug neeg nyeem kuv cov lus qhuab qhia nyob rau peb qhov website tshaj li ntawd 221 lub teb chaws, thiab 40 hom lus – vim yog “kuv ua tau txhua yam los ntawm muaj Yexus ua tug txhawb kuv lub zog.”

Kxh. John Cagan hais tias, “Dr. Hymers tib leeg xwb uas muaj nws lub neej cog rau saum lub pob zeb ua ruaj khov – Yexus tug neeg.”

Nws nrog Vajtswv uake” kuv kov yeej txhua yam kev tawm tsam ua kuv tau ntsib los vim yog – “Kuv ua tau txhua yam los ntawm muaj Yexus ua tug txhawb kuv lub zog” Nov yog qhov peb muaj pawg ntseeg no. Nov yog vim licas, thaum kuv hais kom cov neeg uas kuv tau koj los ntseeg sawv ntsug, tsuas yog ob leeg xwb uas yog xub ntseeg Yexus thiab los lwm qhov los.

Kuv cov phooj ywg uas ncaincees yog, Dr. Christopher L. Cagan, hais tias, “Dr. Hymers yog ib tug neeg uas tiv kev txom nyem, thiab kov yeej txhua yam kev txom nyem thiab qhia tias Yexus yog tug pab lawv thiab.”
